Florida Crime Victims' Bill of Right

Victims of crime or their lawful representatives, including the next of kin of homicide victims, are entitled to be informed, to be present, and to be heard when relevant, at all crucial stages of criminal proceedings, to the extent these rights do not interfere with the constitutional rights of the accused.

• Right to due process and to be treated with fairness and respect for the victim's dignity.

• Right to be free from intimidation, harassment, and abuse.

• Right to, within the judicial process, to be reasonably protected from the accused and any person acting on the behalf of the accused.

• Right to have safety and welfare considered when setting bond

- The right to prevent disclosure of information or records
- Right to prompt return of the victim's property when no longer needed for evidence in the case.
- The right to full and timely restitution.
